## FY23 HIGHLIGHTS

River Edge was awarded another three-year accreditation by CARF International (Commission on Accreditation of Rehabilitation Facilities), the highest award possible. Surveyors described River Edge as a 'spectacular organization' and listed almost four pages of strengths. Of the 2,297 standards that were reviewed, only three recommendations were identified, giving a total score of 99.89%!

River Edge was the first CSB in the state to earn NADD accreditation! This certification will ensure that River Edge continues to provide quality and effective services to individuals with Intellectual and Developmental Disabilities (IDD) through competency-based professional standards and promoting ongoing professional and program development.

A group of individuals supported by River Edge formed the See Me, Hear Me Advocacy Group. This small grassroots group is making a name for themselves in the advocacy community. They visited the Georgia State Capitol building and met with local House of Representatives and Senate leaders. They also participate with Uniting for a Change, Unlock 2.0, and Georgia Council for Developmental Disabilities in attending meetings to learn how to use their voices.

River Edge incorporated integrated medicine in December 2022 by partnering with First Choice Primary Care to provide medical services to individuals.

River Edge's Board of Directors and leadership identified five key areas to focus on building a better future.


## **CERTIFIED COMMUNITY BEHAVIORAL HEALTH CLINIC (CCBHC)**

The Certified Community Behavioral Health Clinic (CCBHC) model is becoming the "gold standard" of care, transforming access to high-quality behavioral health treatment across the country. CCBHCs meet high standards for the breadth of services and quality of care provided. A central theme of the CCBHC model is care coordination – ensuring that the client's needs are addressed across the spectrum of care. Criteria for certification also include advancing Health Equity through evaluating social determinants of health to advance health outcomes for members of marginalized communities.

River Edge is the recipient of a CCBHC grant from the Substance Abuse and Mental Health Services Administration (SAMHSA) that funds planning, development, and infrastructure to meet certification criteria. River Edge's wide range of services, well-trained staff and providers, and commitment to quality care puts the organization in an advantageous position to achieve CCBHC status.

State-certified CCBHCs qualify for enhanced Medicaid payment designed to support the costs associated with expanding access to care. Both state-certified and grantees see benefits to individuals, team members, and the general public.

## **PROGRAM REPORTS**



Diagnostic tests are an important part of supporting and maintaining individuals' overall health. The above represents categories and number of individuals served by age group.


**ADULT SERVICES:** Behavioral Health Assessments (BHA), including admissions, nursing assessments, medication management, and medication administration (injections):

- 1,630 individuals served per month
- 79 individuals served per day
- The three most frequently occurring diagnoses are psychotic disorders, depressive disorders, and bipolar disorders

**CHILD AND ADOLESCENT SERVICES:** BHAs, nursing assessments, medication management, and individual and family therapy:

- 321 individuals served per month
- 34 individuals served per day
- 566 individuals served for therapy
- Georgia Apex Program (APEX): Promotes collaboration between River Edge and schools to provide school-based services and supports, including training for school staff, in hopes of facilitating the right care at the right time for children, young adults, and families:
  - 458 students served
  - o 37 schools in 6 counties

#### INTELLECTUAL AND DEVELOPMENTAL DISABILITIES



Acuity for individuals with intellectual disabilities refers to the severity of the individual's situation.

- **Community Residential Alternative (CRA) Licensed Group Homes:** Serve up to 4 individuals with intellectual and developmental disabilities who require intense levels of residential support:
  - 10 group homes
  - o 34 individuals served
  - 92% occupancy rate
- **Community Living Support (CLS):** Regularly scheduled services in an individual's natural home that help individuals maintain a healthy and productive life at home and in the community:
  - 12 individuals served at 8 residences
  - 92% occupancy rate

#### RIVER EDGE RECOVERY CENTER

Crisis services divert people away from hospitalization and reduce the need for intervention within emergency departments or by law enforcement:

- Individuals in crisis diverted from hospitalization:
  - 30 adult beds with 995 individuals served
    - o 16 child & adolescent beds with 337 individuals served

#### PERMANENT SUPPORTIVE HOUSING SERVICES

Investments in permanent supportive housing have helped decrease the number of chronically homeless individuals:

- Central Georgia area:
  - 482 individuals experiencing homelessness
  - o 143 male
  - o 160 females
  - o 0 transgender
  - o 303 individuals and/or families in housing

#### SUPPORTED EMPLOYMENT

Promotes obtaining competitive work in the community, while providing the support necessary to ensure workplace success.

- 197 individuals applied/referred to Supported Employment services
- 150 individuals served
- 101 individuals employed

#### **FULTON COUNTY**

As a provider for the Fulton County Behavioral Health Network, River Edge provides comprehensive adult mental health and addiction treatment services to all Fulton County residents regardless of their ability to pay:

- **Court Related Mental Health Services:** In collaboration with Magistrate and State Courts, debuted the Misdemeanor Mental Health Court Program (MMHC):
  - DUI 31 individuals completed the year-long treatment portion of the program
  - MMC Incorporated 2 new treatment groups:
    - Living in Balance (addresses wellness and recovery)
    - Thinking 4 A Change (addresses thinking patterns through cognitive behavior therapy). MMC has had 5 individuals successfully complete the year-long program
- **Core Behavioral Health Services:** Provides therapy services for common behavioral issues including depression, anxiety, addiction, and other emotional and behavioral health concerns.
- **Permanent Supportive Housing:** Work with Fulton County to execute its strategies to end homelessness in the County:
  - 3,289 individuals experiencing homelessness
  - o **126 male**
  - o 58 female
  - 1 transgender
  - 185 individuals and /or families in housing

#### PHARMACY SERVICES

River Edge offers provides value-added products and services to Mental health agencies, psychiatric and behavioral health centers, supportive housing and Assertive Community Treatment (ACT) teams:

- Emery Highway location:
  - o 30,146 prescriptions dispensed
  - o 2086 individuals served, including 486 new individuals
- Atlanta location:
  - o 4,305 prescriptions dispensed
  - o 373 individuals served, including 155 new individuals
- River Edge Recovery Center (inpatient):
  - 13,368 prescriptions dispensed
  - o 1,133 individuals served, including 1,003 new individuals
- Acquisition costs (formerly Patient Assistance Program [PAP]): \$541,749.03

#### **RECRUITMENT, HIRING, AND RETENTION**

Over the last years, we have supported our model of care with comprehensive recruiting, hiring, training, and staffing protocols that help our dedicated team members best support the individuals we serve every day. 95% of the training is provided in-house:

- 100% background check compliance
- 100% organizational (core) competencies
- 97% TB test compliance
- 100% credential compliance overall, 90% compliance at the end of Onboarding

Recognition and reward programs were designed to increase engagement, motivate, and retain team members:

- Working Advantage (employee discount program)
- Team member online gifts program 88% participation rate
- Increased team member communication through connective communication methods

# **CAPITAL PROJECTS**

**INTELLECTUAL & DEVELOPMENTAL DISABILITIES (IDD) CRISIS STABILIZATION AND DIAGNOSTIC CENTER (CSDC):** The first of its kind in the state of Georgia, this Georgia Department of Behavioral Health, and Developmental Disabilities (DBHDD) initiative offers a broad range of healthcare services for adult individuals with IDD to include the following:

 Short-term 24/7 crisis stabilization unit with 16 beds providing integrated behavioral health services

Developmental Medicine providing quality care in a patient-centered and family-focused environment providing:

- Behavioral health
  assessments
- Dentistry
- Psychiatry
- Neurology

- Physical therapy
- Occupational therapy
- Speech and language pathology
- Ophthalmology
- Other primary care specialist services

The total development cost is \$20 million, with an estimated completion date of January, 2025.

**NEW MACON-BIBB HEADQUARTERS AND OUTPATIENT CLINIC:** River Edge is developing the next generation of behavioral health facilities to use design innovation as part of treatment and recovery. The building design will directly enhance individuals' care and will directly enhance our mission to provide high quality care.



**PEER SUPPORT COMMUNITY INTEGRATION ADULT CENTER:** Supports the concept of recovery – a way of living a satisfying, hopeful, and contributing life even with limitations that may be caused by mental illness. Our community integration services strive to provide the resources and activities to assist individuals in their growth and improvement in the areas of health, education, and emotional well-being. Our trained peer support specialist gives advice and guidance, provides insight, shares information on services, and empowers the beneficiary to make healthy decisions. Group therapy will be designed to target a specific problem, such as coping

*Concept Image* Group therapy will be designed to target a specific problem, such as coping with depression. Other groups may focus more generally on issues, including improving social skills or helping you deal with emotions, such as anger or loneliness. Construction is anticipated to begin in 2024, with completion by 2026.



**TINY COTTAGES OF MACON PERMANENT SUPPORTIVE HOUSING:** Macon-Bibb County appears to be in an affordable housing and mental health crisis. Every day, we see the impacts of poverty, mental illness, and chronic health problems on our streets, along our highways, and in our neighborhoods. People are struggling to pay rent, and many of our neighbors are destitute. In Macon-Bibb County, there are approximately 250 PSH units which have a 100% occupancy rate and 96% success rate at keeping people from re-entering homelessness. Tiny Cottages of Macon is a

new, innovative PSH project for chronically homeless adults that will consist of ten (10) single-family "Tiny Cottages". Each cottage will provide 670 square feet of living space featuring a living, bedroom, kitchen, bathroom, hallway, closet, and dining space. Construction of Phase I five (50 units began August 2023. Phase II construction is anticipated to begin in October 2023, with completion by February 2024.

**SERENITY COURTYARD OF MACON PERMANENT SUPPORTIVE HOUSING:** Received multiple finding sources to develop 26 affordable housing units for senior persons 55 and older:

- Georgia Investment in Housing Grant: \$4,788,334
- Macon-Bibb County HOME Funds: \$600,000
- Community Foundation of Central Georgia Grant: \$20,000
- REdge Foundation \$600,000

Construction is anticipated to begin in October 2023.


River Edge's IT Department successfully migrated the entire organization to Microsoft Office 365, a cloud-based office system for all River Edge team members.





The Revenue Analysis identifies the source of funding received in FY23




The Expense Analysis shows how and where River Edge used the Revenue in FY23




# Gross Margin - FY'23
